**DATE OF SALES:** To begin Wednesday, May 10, 2023 at 12:00 PM and conclude on Sunday, May 14, 2023 at 6:00 PM. Lots will have a staggered and soft close.

**BUYERS PREMIUM:** There will be a 10% buyer's premium added to all bids and included in the total purchase price of ALL items.

**CREDIT CARD AUTHORIZATION:** Users will be required to make a cc authorization of \$1.00 in order to bid. These authorizations will be released after the auction is completed.

**PICKUP & PAYMENT:** *Pickup will occur Tuesday, May 16, 2023 between 11:00 AM and 5:00 PM* (timeframe subject to change at the auctioneer's discretion). Buyer will have an option to schedule an appointment for faster checkout. Buyer will be responsible for packing materials/boxes and additional labor for large items. Small items will be brought out to the buyer by a member of the auction team. Property is located in Lawrenceburg, KY. The property address will be emailed to winning bidders.

**Payment will be due in full to HALFHILL AUCTION GROUP, LLC at the TIME OF PICKUP.** You will have an option of **PAYING YOUR INVOICE ONLINE** (3% CC fee applies). Accepted methods of payment are *cash, personal/business check, Visa, MasterCard, Discover, and American Express* credit cards (no debit cards accepted). There will be a 3% Convenience Fee added to all credit card transactions. All items must be paid in full before they can be removed from the property. *If bidder fails to make payment and/or fails to pickup items on scheduled pickup time, items will be forfeited and credit card on file will be charged for items within 24 hours of failure to communicate, pay or pickup.*

**SALES TAX:** Kentucky Sales Tax (6%) will be added to the purchase price. Dealers or other exempt parties must provide proper documentation to Auctioneer before bidding or will be charged the sales tax.

**AUCTION END TIMES:** Halfhill Auction Group Online Auctions are timed events and bidding will close at staggered time intervals. Halfhill Auction Group Online Auctions also have an auto extend feature. If a bid is placed in the final 2 minutes of the auction, the close of the auction will be automatically extended 2 minutes from the time the bid was placed. For Example: If an auction scheduled to close at 4:00 PM receives a bid at 3:59, the close will automatically extend to 4:02 PM. The auto extend feature remains active until no further bids are received within a 2 minute time frame.
