**ITEM PICKUP:** All items must be paid for in full before removed from auction site. Most items will be brought by the auction staff to the check-out area for pick up. **PAYMENT:** Payment will be due in full to HALFHILL AUCTION GROUP, LLC at the time pickup on August 30th. Accepted methods of payment are cash, personal/business check, Visa or MasterCard credit cards (no debit cards accepted). There will be a 3% Convenience Fee added to all credit card transactions.
